Puerto Rico's world-renowned culture supports a vibrant creative industries economy


Culture and the creative industries are alive in Puerto Rico and making their mark all over the globe. We are recognized worldwide for contributions to salsa and reggaeton, but also have a vibrant film production scene, media, web/ software design, museum culture, skilled artisans, street fairs, and more. Our history and spirit make the Island an ideal spot to take advantage of the unique mix of Latin, Caribbean, and U.S. cultures.

Our unique arts and cultural economies are showcased annually in the multi-day San Sebastian street festival in Old San Juan, at the Fiestón Cultural, and at annual local festivals hosted across the Island's municipalities. These industries contribute to the larger local talent pool, particularly in the knowledge services for design, architecture, planning, and other aspects of business development.

The creative industries act as an economic representation of culture, showcasing Puerto Rico's high quality of life internally and abroad. The global impact of Puerto Rican music provides an insight into what our creative industries can achieve, as well as the cultural and business opportunities the Island offers.

Unique Incentives

The Puerto Rico Incentives Code provides attractive tax credits for creative industries.

Puerto Rico has served as a backdrop for many famous movies thanks to its convenient proximity to the US, film industry tax incentives, diverse landscape, and versatile locations.

From fiscal year 2016 through 2019, nearly 100 films were shot on the Island. These contributed \$424 million to the local economy.

Unique Incentives for Film & TV Projects

Eligible activities, under the Puerto Rico Incentives Code, for businesses in creative industries include, but are not limited to: film projects, TV projects, video games, music videos, and film festivals.

Tax Credit on Film Production Projects:

- Up to 40% for production expenses paid to Puerto Rico residents
- ✓ Up to 20% for production expenses, related to payments to non-resident workers
- Up to 15% of production expenses paid to Puerto Rico residents (with a \$4.0 million maximum) for co-productions with local producers

Tax Rates or Exemptions for Persons Engaged in Qualifying Film Projects:

- 4% fixed income tax rate
- 100% exemption on dividend taxes and municipal license taxes, excise taxes and other municipal taxes
- 90% exemption from municipal and state taxes on property

- Proven track record for delivering on schedule and on budget
- Diversity and proximity of locations

- Equipment and crew available to supply several productions simultaneously
- Soundstages (TV) and warehouses for building and filming on sets

- Overnight dailies (3 or 4 hours ahead from Los Angeles time)
- Availability of government locations at no cost
